

Inaccurate OSHA recordkeeping and reporting have resulted in single company fines in excess of \$1,000,000 for employers. OSHA recordkeeping and reporting violations can yield penalties of up to \$10,000 per occurrence and can also result in criminal prosecution proceedings initiated by OSHA through the Federal Department of Justice. One hundred percent (100%) accurate records are a must.

#### Effective Safety and Health Programs

The benefits of a workplace safety and health program will include the benefits of preventing accidents and injuries, compliance with OSHA regulations, and lowering the cost of doing business. OSHA requires that employers adopt certain safety and health standards reasonably necessary to protect workers on the job.
