

## **OVERVIEW**

Small business is the lifeblood of our community and the driving force of jobs in South Carolina. As part of our core constituency, the South Carolina Chamber's grassroots efforts and overall success is directly tied to our ability to foster a climate that is favorable to small business.

For this reason, the South Carolina Chamber of Commerce has introduced the South Carolina Chamber Federation, a partnership with local chambers to ensure the voice of small business is heard with minimal investment and maximum impact.

Through the South Carolina Chamber Federation, any business with 10 or fewer full time employees who is a member of a participating local chamber will receive free membership into the South Carolina Chamber of Commerce.

Participation in the Federation gives local chambers a sales and retention tool, increased influence in the state legislature and access to timely information, resources and opportunities.

This partnership aims to empower small businesses and grow the voice of business at the local, state and federal levels.

## **AGREEMENT**

The South Carolina Chamber	r Federation Agreement (hereinafter "Agreement") is effective a

Commerce (hereinafter "Sout	th Carolina Chamber") and the		
Chamber of Commerce (hereinafter "Local Chamber"). Due to the following common			
objectives, the South Carolina Chamber and the Local Chamber have entered into this			
agreement:			

- 1. Strengthen the positive and beneficial relationship that exists between state and local chambers in South Carolina.
- 2. Through cooperative efforts, increase the legislative and political involvement and effectiveness of the South Carolina small business community.
- 3. Through cooperative efforts, increase the opportunity to provide beneficial programs and services to chamber members.
- 4. Increase membership and loyalty for both the South Carolina Chamber and Local Chamber.

#### I. SOUTH CAROLINA CHAMBER MEMBERSHIP

The Local Chamber shall be a member in good standing of the South Carolina Chamber. Upon the expiration of the membership of the Local Chamber in the South Carolina Chamber, termination of all agreements between the parties may occur. Appropriate notice will be given prior to any such removal.

#### II. FEDERATION MEMBERS

All active members of the Local Chamber who employ 10 or fewer full-time employees shall be South Carolina Chamber Federation members (hereinafter "Federation members") upon execution of this agreement. Each will have the opportunity to opt-out should they choose not to participate in the Federation.

#### III. FEDERATION COMMUNICATIONS

The South Carolina Chamber shall ensure that Federation members receive all communications through either the "Direct to Member" option which permits the South Carolina Chamber to manage the communication process or the "Direct to Local Chamber" option which permits the Local Chamber to manage the communication process. A Local Chamber may change the communication option by providing written notice to the South Carolina Chamber; the South Carolina Chamber, however, may not alter the communication option with the Local Chamber or Federation members without written authorization.

By choosing one of the communication options, the Local Chamber agrees to provide the necessary contact information as referenced in the South Carolina Chamber Federation Partner Information Form (attached). While Federation members may voluntarily opt-in to communications from the South Carolina Chamber, Federation members may also opt-out of any and all contact lists at any time via communication links or by contacting the South Carolina Chamber directly.

#### IV. LEGISLATIVE ADVOCACY

As a proactive legislative advocacy organization, the South Carolina Chamber shall encourage Federation member involvement in communications with elected officials on legislative and regulatory matters before state and federal government. As a part of Federation involvement, the South Carolina Chamber shall inform the Local Chamber of all communication sent to Federation members and/or include the Local Chamber in the communication.

### V. FEDERATION PROMOTION

Both the Local Chamber and South Carolina Chamber have the right to promote the benefits and structure of the Federation during the recruitment and retention of small business membership. By choosing to participate in the Federation, the Local Chamber agrees to incorporate the benefit of "a complimentary Federation membership in the South Carolina Chamber" into the sales process for potential and current members who have less than 10 employees. The South Carolina Chamber will develop and provide co-branded promotional material for use by the Local Chamber.

### VI. TERMINATION OF AGREEMENT

Either party is permitted to terminate this agreement with 30 days' notice provided in writing. The South Carolina Chamber is permitted to continue communication and services in full to
